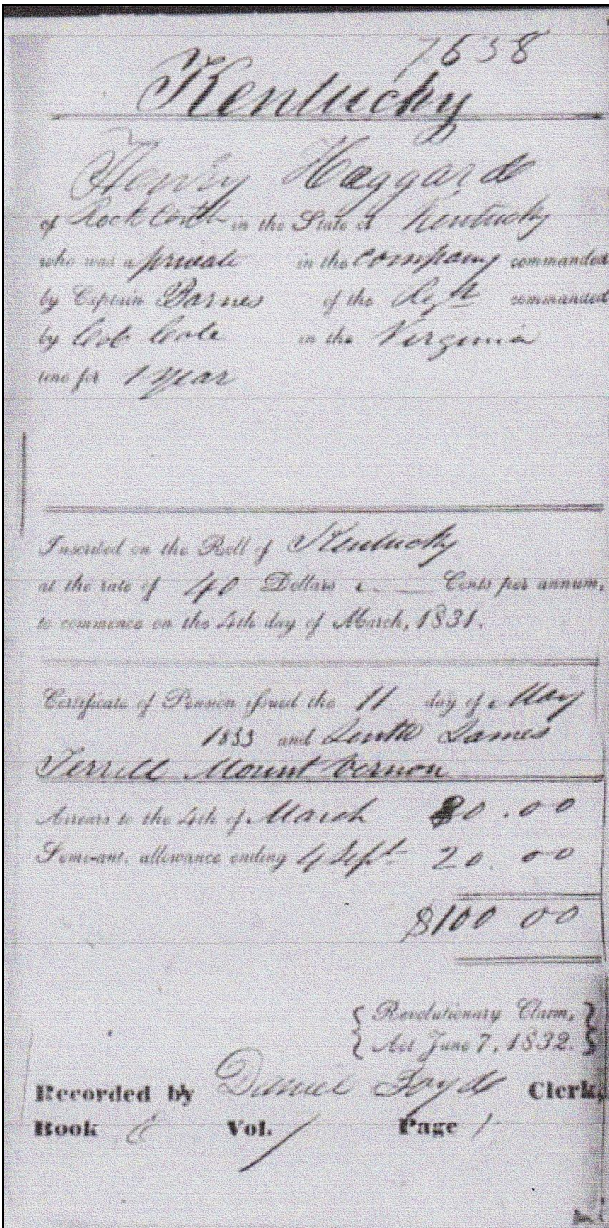
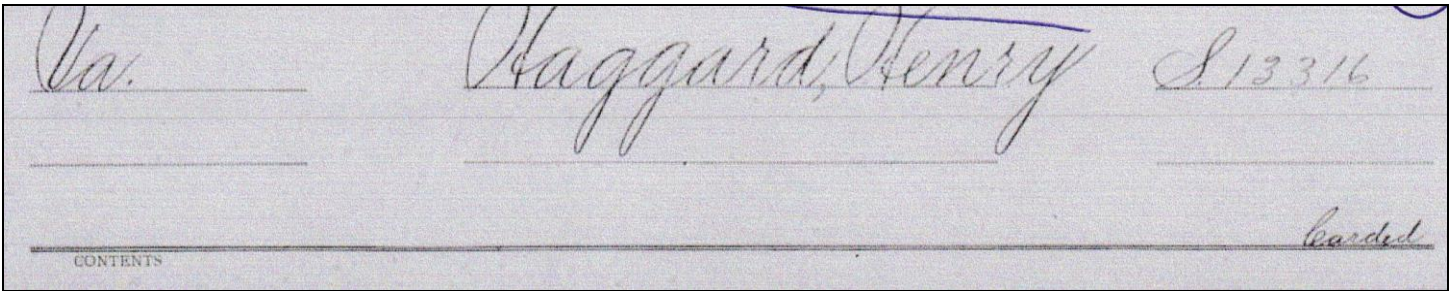


**HENRY HAGGARD**



There is some uncertainty on this Soldier/and or Patriot. The D.A.R. record for him gives his status as a 'Soldier of North Carolina', born c. 1744/45 in Virginia with a wife named 'Doratha' [Dorothy] Randolph. Descendant information says Dorothy (1746-1813) died in Crowson's Cove in Sevier County, Tennessee. This man according to the D.A.R. died in Alabama in 1842, but he is not shown as a Pensioner in the D.A.R. book. Yet, a man of this name is included in the 1831 Pensioner Listing while living in Bibb County, Alabama, age 94.

Descendants of Henry Haggard applied for and were approved for the designation as "First Families of Tennessee" by the East TN Historical Society. A North Carolina Land Grant was awarded for 300 acres on Sisles Creek [location not known]. On June 1, 1810, a man of this name owned 180 acres of land on French Broad in Sevier County. He is presumably the Patriot Ancestor.

What is without question, is to draw a Pension, a man had to be a Soldier. 'Patriot' services did not qualify. This man is thought to be buried in Cahaba Valley Baptist Church Cemetery in Bibb County, Alabama. A Find-A-Grave posting cites D.A.R. as: Service North Carolina; "Patriotic Service"; source, NC Revolutionary War Pay Voucher #2120, Roll #S.115.93, "Paid for services rendered." This man is enumerated in the 1840 census of Bibb County, Alabama.

Another man of this same name served as a Soldier in Virginia. This man applied for and drew Pension, S13316. This man was in Rockcastle County, KY by 1820, age 60-69, and in 1830, he is shown as age 70-79. He was placed on the Pension Roll in 1831. Whether they are one and the same man cannot be readily determined. Only one Pension Record [service in Virginia] is found for Henry Haggard.

Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

State of Kentucky Rockcastle County & Circuit Ct.

On this 12<sup>th</sup> day of September personally Appeared before the Judge of the 15<sup>th</sup> Judicial Circuit of Kentucky Henry Haggard age seventy-four, 25<sup>th</sup> of March next who resident of the County aforesaid being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provisions made by the Act of Congress passed June 7<sup>th</sup> 1832. That he volunteered in the Militia in the Army of the United States in the year 1776 as well as he recollects in the Militia Company commanded by Captain Barnes Brown in the Regiment commanded by Colonel Cole in the Virginia line for the term of six months. This volunteering took place in Albemarle County State of Virginia where he lived and entered the Service. He served out his tour of enlistment when he was discharged in the same County by his Captain aforesaid. In August 1778 in Washington County State of Virginia he was drafted for a period not now recollected his Captain was Duncan in the Regiment commanded by Colonel Campbell [William Campbell] who commanded at Kings Mountain in North Carolina [sic, South Carolina], but he was discharged at Abingdon Virginia by Captain Duncan before his term of Service expired, but it was in Luke of the tour of three months. In 1780 in Sullivan County (Tennessee) then North Carolina he was drafted for six months in the Company of Commanded by Captain Solomon White in the Regiment commanded by Isaac Shelby formerly Governor of (Kentucky). He served a portion of his time a little upwards of three months but he cannot remember the time but was discharged by his Captain aforesaid on Broad River South Carolina. The second enlistment he lived in Washington County the third he lived in Sullivan County (Tennessee). He hereby relinquishes every claim whatever to a pension or annuity except the present and he declares his name is not on the pension Roll of any Agency in any State. Sworn & subscribed to this day and year aforesaid.

1<sup>st</sup> Where and in what year were you born. I am 74 born in Albemarle County Virginia. Have you any record of your age and if so where is it. Ans. None. The place of entering the Service he has fully explained, since the Revolution he lived in Hawkins and Sullivan Counties Tennessee and for about forty years he has lived in (Kentucky) Rockcastle County where he now lives. To 4 questions he has fully explained. He does not recollect of the names of any regular officers or regular troops while he was in Service by whom he was discharged. He has stated all he knows all of which he has long since lost. He received no Commission being a private

Soldier. As to his character he refers to Captain James W Anderson, General William Smith and to the Reverend John Quin living in the County, for his County character for veracity and the belief of his Service.

[John Quin, an ordained minister of the gospel, William Smith and James W Anderson gave the standard supporting affidavit.]

[Veteran was pensioned at the rate of \$40 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for one-year in the Virginia service.]

General Accounting Office
