I certify that, in conformity with the law of the United States of the 7th June, 1832, Frederick Burkett of the State of Tennessee who was a Private in the Army of the Revolution is entitled to receive Thirty dollars and cents per annum, during his natural life, commencing on the 4th of March, 1836 and payable semi-annually on the 4th of March, and 4th of September in every year.

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

For the purpose of obtaining the benefits of the act entitled an act for the relief of certain surviving officers and Soldiers of the Army of the Revolution approved on the 15th May 1828 I Frederick Burket of the County of Greene and State of Tennessee do hereby declare that I enlisted in the Continental Line of the Army of the Revolution for and during the War and continued in its service until the termination for which period I was a private in Capt. Smith's company commanded by Col. Morfett [sic, George Moffett] in the Regiment from Staunton Virginia, this declarant is upwards of seventy-eight or nine years of age he was Cut with a Sword at the battle of Guilford and was in several battles which he had his discharge for and has lost it his memory is bad being old and infirm cannot recollect the Regiment to which he belonged he also declares that he afterwards received certificates for the reward of \$80 to which he was entitled under a resolve of Congress passed 15th May 1778 and further declares that he was not on the 15th day of May 1828 on the Pension list of the United States.

Revolutionary Claims

Fredrick Burket of __ in the County of Green in the State of Tennessee has applied to the Secretary of the Treasury for the benefits of the act, entitled "An act for the relief of certain surviving officers and soldiers of the Revolution," approved the 15th of May, 1828. He states that he enlisted in the Continental line of the Army of the Revolution, for and during the war, and continued until its termination, at which period he was a Private in Captain Smith's Company, in Col. Morfatt's [sic] regiment of the Virginia line; and that he received a certificate for the reward of eighty dollars, provided by the resolve of the 15th of May, 1778; and further, that he was not on the 15th of May, 1828, on the pension list of the United States, and that he has received as a pensioner since the 3rd of March, 1826, nothing

Under the Act entitled an act for the relief of the Surviving officers and soldiers of the Army of the Revolution approved on the 15th May 1828

Before me Robert Maloney a Justice of the Peace in the County of Greene and State of Tennessee personally appeared Charles Dyke¹ Seventy years of age -- and made oath that Frederick Burket who has applied for a pension under the above mentioned act did serve in Capt. Smith's Company of Augusta State of Virginia And that he enlisted for and during the war and continued in the service until its termination and that the said Burkett received toward the Close of the war a shot that wounded his head and that by excessive fatigue he became an invalid and remained so some years after and now is very poor and has nobody to do the least thing for him but his wife who is something like Seventy years of age.

State of Tennessee Greene County

On this 10th day of June 1833 personally appeared before me John Balch one of the acting Justices of the Peace in and for the said County of Frederick Burkett a resident Citizen of the County & State aforesaid aged eighty-one years who being first duly sworn according to law

doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed the 7th of June 1832 that he entered the Service of the United States under the following named officers & served as herein stated to wit that in the year 1777 he was enrolled as a volunteer under Col. Moffet [George Moffett] in Capt. Smith's [probably either Daniel Smith or Thomas Smith both of Augusta County militia and both of whom were in the battle of Guilford Courthouse] Company in the Virginia Militia for the term of 3 months that he entered said Service in Augusta County Virginia and joined the Main Army at Stantown [sic, Stanton or Staunton?] & was marched under the command of Col. Moffett and Capt. Smith through Virginia by way of the high rock Ford to Gilford [sic, Guilford] North Carolina where he was in the Battle of Guilford² and was severely wounded in the neck & continued in said Service until March in the same year when he was discharged by Capt. Smith at or near the high rock Ford he further declares that he was previously enrolled as a Soldier for a tour of duty in the County of Augusta State of Virginia under Capt. Bohannon [probably Patrick Buchanan] & Capt. Wall [? could be "Noll" perhaps a reference to Capt. William Nail] & was marched by way of the big Savannah to Green brier & served three months and was discharged in Augusta County [p 3] Virginia he further states that he served three months to the Battle of Germantown [October 4, 1777] was marched through Resel town [sic ?] Virginia he further states that he served a three months to the Albemarle Barracks as a guard to guard the prisoners he further states that he served three months tour to Bluford's defeat [sic, Buford's Defeat or the Battle of the Waxhaws, May 29, 1780] he further states that by reason of old age & loss of memory & at this time almost death he is unable to give proper information in regard to his officers whom he served under -- having served in the whole the term of one year & three months that he has no documentary evidence & that he knows of no person whose testimony he can procure who can testify to his Service. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State

Questions by the Justice

1. Where & in what year was you born --

Answer -- in the year 1752

2. Have you any record of your age

Answer -- I have not

3. Where were you living when called into Service where have you lived since the revolutionary war and where do you now live

Answer -- I. lived in Augusta County Virginia when I was called into service & have lived in Tennessee since the war & I lived at this time in the County of Greene Tennessee

4. How were you called into service were you drafted did you volunteer or were you a Substitute

Answer I volunteered to the Guilford battle & the other 4 tours I was drafted

5. State the names of some of the regular officers who were with the troops where you served such Continental & Militia regiments as you can recollect and the general circumstances of your Service

Answer General Greene [Nathanael Greene] was the commander in Chief at the battle of Guilford & any of the other officers I cannot recollect at this time

[p 5] 6. Did you ever receive a discharge from the service and if so by whom was it given & what became of it

Answer I never did receive a discharge in writing

7. State the names of persons to whom you are known in your neighborhood and who can testify



State of Tennessee Hawkins County: Magistrates Office 10th July 1834

On this 10th day of July 1834 personally appeared before me Jesse Creech one of the acting The justices of the Peace in and for the County aforesaid Frederick Burket a resident of Greene County Tennessee aged 83 years old next August, who being first duly sworn according to law, doth on his oath make the following Declaration, in order to obtain the benefit of the Act of Congress, passed June the 7 1832. That he entered the service of the United States under the following named Officers, and served as herein stated: This Applicant states that he was born in Philadelphia County in the State of Pennsylvania on the 15th day of August 1750, that he has no record of his age, nor was there ever one as he knows of, but he recollects that his parents told him about his age which is as above stated. This Applicant further states that he was living in Augusta County State of Virginia when he first entered the service of the United States as a volunteer under Capt. David Bell in the year 1776 the month he does not remember that they were called out by the United States to march against the Indians, who were harassing the frontiers. That the company rendezvoused at the house of Capt. Bell, and from there were marched to Green Briar & from thence across the mountains, that they remained among the Mountains for some time without being stationed at any particular place that he is unable to state further particulars of his service, neither can he name the rest of his officers, it having been so long & he now being so old & nearly deprived of his recollection of these times, but about the time he entered the service & the length of time he served he is not mistaken for he calculates the time he entered the service by the age of his first child, & he is certain that the Term took three months the time for which the volunteers were called out. That from this expedition they returned home & were dismissed from the service without receiving a written discharge.

This Applicant further states that he again entered the service as a volunteer in the year 1780 or 81 the month he does not remember under Capt. Smith & Lieut. Christy [probably Lieutenant Robert Christian] & Col. Monford commanded the Regiment that the company to which this Applicant belonged rendezvoused at Santon [sic, Staunton?] & from thence the Regiment was marched across Little Deep River & Dan River & the High rock Ford & on to Guilford way her under the command of General Greene they fought the Battle of Guilford in which battle he was wounded in the neck by a Musket Ball, from the Battle of Guilford they marched to the Troublesome Iron works & from thence home that he never received a written discharge from the service. This Applicant further states that this Term of service lasted three months. This Applicant further states that his father was named Frederick Burket & served

before the revolutionary War against the Indians, but that all his service was during the Revolutionary War. This Applicant further states that he hired substitutes for the term of 18 months during the war for which he is advised he cannot draw. This Applicant further states that he is now 83 years old or nearly so, & that he is very infirm on account of which he is unable to attend Court & his memory is very much impaired so that he is unable to relate a great many circumstances of his services, & has forgotten some of his Officers, but as to the length of his services he can recollect which is not less than above stated making in all six months & for such service he claims a pension. He further states that he cannot name any regular or Continental forces in the service with him. This Applicant further states that he has no documentary evidence of his services. He further states that the reason he applied in Hawkins County is that he lives near the line & that the nearest Magistrate to him lived in Hawkins & he is unable to go far & that he is as well known in Hawkins & Greene County. This Applicant further states that he never received a Commission. He further states that he has lived since the Revolutionary War in Virginia & Tennessee & does now live & has lived in Tennessee for the last 25 years. This Applicant further states that there is no Clergyman in his neighborhood & that he knows of no one now living by whom he can prove his services but that he is well known in his present neighborhood to William Keel and John Roden -- who can testify to his character for veracity & their belief of his services during the Revolutionary War. He hereby relinquishes every claim whatever to a pension or annuity except the present, & declares that his name is not on the pension Roll of the Agency of any State or (if any) only on that of the Agency of the State of Virginia.

[William Keel and John Roden gave the standard supporting affidavit.]

[Veteran was pensioned at the rate of \$30 per annum commencing March 4th, 1831, for service as a private for 9 months in the Virginia Continental line.]

Frederick Burket was in Greene County, Tennessee by 1810 when he appears in a tax list owning 100 acres on Waters of Lick Creek. He is enumerated as "Burkhart" in the 1830 Census, age 70-79, with a wife, age 60-69. In the adjacent household was Isaac Burket, age 30-39, who is presumed to be Frederick's son.

Frederick is shown in the 1835 Greene County Pensioners List as age 82. He probably died before the 1840 Census. In 1840, Frederick's presumed son, Isaac, lived in Rhea County, age 30-39. In 1850 Isaac Burket lived in Hamilton County, Tennessee, and in his household was a named son, Frederick, age 19.

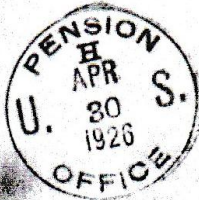
