[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call errors or omissions to my attention.]

The Memorial of William Sitton, a citizen residing in Green County in the State of Tennessee setteth forth – that in the year 1774, he served as a militia man and was at the Battle of the Point near the Ohio River fought with and against the Delawares, Shawnees and other Indians; at which battle Colonel Charles Sevier [?]<sup>1</sup>, Major Guilds [?]<sup>2</sup>, and several other officers and privates were killed – That he the memorialists afterwards enlisted as a private Soldier with John Lapsly [John Lapsley] who then was an Ensign in Captain Thomas Posey's Company in the 7th Virginia Regiment on the Continental establishment for the term of two years – that he continued in said Company and in said Regiment during the time said Regiment was in active service in Virginia against Lord Dunmore and his troops – that he afterwards marched with said Regiment early in the year 1777 to the northward and was at the Battle of Germantown [October 4, 1777] – and after the said Battle the said term of two years having Expired, this memorialists reenlisted in the same company, in the said Regiment for the term of three years – during which term this memorialists faithfully served as a private Soldier in said Company & Regiment – which continued terms of service amounted to five years – this memorialists having suffered great fatigue and his health being considerably impaired during said service at the expiration of said term returned home to Virginia – this memorialists states that he afterwards joined as a militia man in several tours of duty against the enemy, the British in Virginia; that he was wounded in the head – that he afterwards was at the Siege of York in the company of Militia commanded by Captain John Lewis [?]<sup>3</sup> – and was present when Cornwallis with his Army was captured [October 19, 1781] – this memorialists states that he is now [indecipherable word, could be 'progressing?'] in the seventy fourth year of his age – that he has raised a family of children, who are all married and gone from him – that he is left with his wife who is also far advanced in years – that he is infirm as well by age and infirmity, as by the effects of the wound in his head, is without property to support him, and in Indigent Circumstances – he states that he faithfully served as a private Soldier during the said term of five years in the Army of the United States on the Continental Establishment, besides several tours of duty as a Militia man, as above mentioned, in the time of the Revolutionary War between the United States of America and Great Britain – and he now prays that he during the residue of the term of his life in this world, maybe allowed the sum of \$8 per month – pursuant to a late act of Congress providing support for the Officers and Soldiers of the United States, on Continental establishment, who served nine months or more – in the said War in the Army of the United States of America, and this memorialists well ever be grateful to his Country for the said support in his old age [indecipherable word or words]<sup>4</sup> man high degree helpless and infirm in consequence of services rendered by him in aiding to establish the Independence and freedom of Self Government of his Country the United States of America.

State of Tennessee Greene County: On the 25th day of October 1820 personally appeared in Open Court being a Court of Record with Jurisdiction unlimited in point of amount, keeping a Record of their proceedings, also having power of Fine and Imprisonment, for the County and State aforesaid – William Sitton aged seventy-eight years who being first duly sworn according to law doth on his oath make the following Declaration, in order to obtain the provision made by the acts of Congress of the 18th of March 1818 and the 1st May 1820. That he the said William Sitton enlisted for the term of two years in the year 1776 in the State of Virginia in the Company commanded by Captain Thomas Posey in the Regiment commanded by Colonel Alexander Mceleheny [Alexander McClanachan] in the line of the State of Virginia on the Continental establishment – that he continued to serve in the said Corps until the end of the two years then reenlisted for the Term of three years in the said line and under the same officers and continued to serve in the said Corps until the expiration of the three years when he was Discharge from the service in Botetourt County in the State of Virginia. That he was in the Battles of Germantown, Chestnut hills [? Chestnut Hill Ridge, December 6, 1777, part of the Battle of White Marsh], at the siege of York taking Corn Wallis and that he has no other evidence now in his power of his said services except his own Oath, and in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled “an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war” passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

**WILL OF WILLIAM SITTON:**  
[William Setton married Susannah Hennesey on July 7, 1779 in North Carolina.]



Whereas, I, WILLIAM SITTON, of Greene County and State of Tennessee, being sick, and in a weakly condition, and calling to mind that it is anu appointed for all men to die, do make and ordain this my last Will and Testament, and dispose of such worldly property as it hath pleased the Almighty to bless me with in the following manner: And first,

I will that after my decease, my body be interred in decent Christian burial, and that my funeral charges and all my just debts be paid out of my estate by my executors.

Item. I give and bequeth **to my beloved wife, Susanna Sitton**, all my personal estate for her support and maintenance during her natural life and after her decease that part of said estate that then remains to be disposed of, as herein directed, that is to say:

I give and bequeth to **my little granddaughter, Susanna Sitton, who now lives with me**, one milking cow and calf, two sheep with their respective increase; one small walnut table, a small walnut box, all the kitchen potware, and all dressers or cupboard dishes, consisting of pewter, dishes and iron articles; one feather bed and its furniture, I also give unto my said granddaughter the sum of twenty dollars in money, to be applied to the payment for her schooling, by my executors; and the other part of her legacy to be paid, or delivered to her, when she shall arrive at the age of Eighteen years or on her marriage, by my executors.

Item. I will that after the decease of my beloved wife aforesaid, that what remains of my estate be sold and that the monies arising therefrom be equally divided amongst my children, that is to say, the children of those of my children that have deceased, to have a child's part divided amongst them by my executors at their arrival at lawful age to receive it.

Item. I constitute and appoint Abraham Collet and Henry Earnest, the sole executors of this my last will and testament and I do hereby revoke and disavow all former wills and testaments by me made, ratifying this and this alone, declaring and pronouncing it to be my last will and testament. In witness whereof I have hereunto set my hand and affixed my seal the daythird of August 1823.

And we whose names are subscribed hereto as witnesses did hear the said William Sitton, declare and pronounce this to be his last will and testament, and saw him sign and seal the same and who in his presence and in the presence of each other did sign our names in testimony of the same.

### Postscript

William Sitton's date of death is not known; however, on April 28, 1823, the Greene County Orphan Court appointed Thomas Stanfield so be the Guardian of Susannah Sutton, a "minor orphan". Susannah appears to be the granddaughter named in William's Will.

William's son, Samuel, was a soldier in Captain James Penney Company, War of 1812. Samuel died in 1816.

Dear Madam:

Reference is made to your letter in which you request the records of James and John Price and William Sitton, soldiers of the Revolutionary War.

The record of William Sitton which follows is obtained from the papers on file in pension claim, S. 39073, based upon ~~his~~ service ~~in~~ that war.

William Sitton, a resident of Virginia, place not stated, served in the Virginia militia in 1774 and was in the battle at the point near the Ohio River against the Indians in which Colonel Charles Lewis, Major Fields and many privates were killed.

He enlisted early in 1776, served as a private in Captain Thomas Posey's Company, Colonel Alexander McClanachan's 7<sup>th</sup> Virginia Regiment, was in active service against Lord Dunmore in Virginia, was in the battles of Germantown and Chestnut Hill, and was discharged at the expiration of service of five years; he subsequently served several tours against the British in Virginia and was wounded in the head, officers not named and no details in regard to said wound given; he served a tour in the militia in a company commanded by Captain John Lewis and was at the Siege of Yorktown and surrender of Cornwallis, length of this tour not stated.

He was allowed pension on his application executed September 9, 1818, at which time he was a resident of Greene County, Tennessee. He was then about seventy-six years of age, the date of his birth not shown.

At the time he made application for pension, William Sitton stated that he had raised a family of children, all of whom were married and away from home, but he did not give their names. In 1820, his wife, Susanna Sitton, was seventy-four years of age, and his granddaughter, Susanna Sitton, aged six years, lived with them, the names of her parents not stated.

The above record is that of the only soldier named William Sitton, found on the Revolutionary War records of this office.
